Legislative Action

Last week, I introduced Senate Bill 67, also known as the Bring Small Business Back Georgia Regulatory Reform Act. The act will remove unnecessary government regulations that threaten the growth and creativity of small businesses. A cost benefit analysis will be required for any new rule; and if a new rule is deemed necessary, two existing rules will be removed. However, rules impacting public safety will not be removed. I am also working with the Job Creators Network and their CEO, Alfredo Ortiz on this legislation to make it an example for the rest of the nation to follow.
